Pan Am Senior Poomsae and Kyorugi Championships General Information

- Kyorugi Competition**
1. Each PATU Member National Association (MNA) may enter NO more than ONE (1) competitor per weight division. The maximum number of competitors per MNA is sixteen (16), plus any Wild Card invitation holders. No more than 2 athletes for each weight categories per MNA including the Wild Card invitation holders.

8 Official Weight Categories
x 2 Divisions (Male & Female)
16 Competitors Maximum per National Teams

2. Wild Card Invitation holders from 2017 WT President's Cup

Eligibility

1. Holder of the nationality of the participating team
2. Holder of 2018 WT Global Athlete License (GAL)
3. Holder of Dan recognized by WT, PATU, PATU MNA, or Kukkiwon National Team Member of WT/PATU
5. All athletes participating in 2018 Pan Am Senior **Kyorugi & Poomsae** Championships must be born on/or before December 31, 2001 (at least 17 yrs. of age).

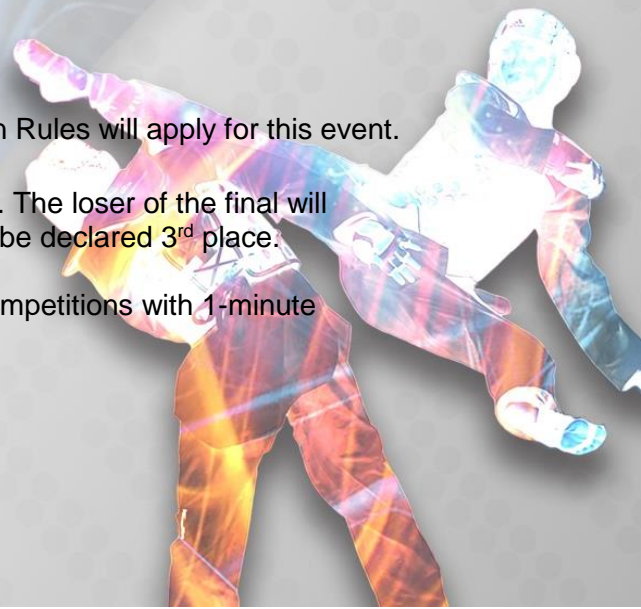
The latest WT Sr. Kyorugi Competition Rules will apply for this event.

Competition System

Single elimination tournament system. The loser of the final will be 2nd place. Losers to semifinals will be declared 3rd place.

Kyorugi Contest time

Three (3) rounds of Two (2) minute competitions with 1-minute rest time between each round.



PAN AM CHAMPIONSHIPS

Poomsae Competition

1. Each PATU Member National Association (MNA) may enter NO more than TWO (2) competitors for Individual Poomsae Competitions, and only One (1) team for Pairs, Male Team, Female Team, and Free Style Team Competitions.
2. Poomsae Wild Card Invitation holders from 2017 WT President's Cup.

Coaches Qualification

Coaches minimum qualification requirements are;
All coaches must be at least 18 years of age.
All Coaches / Trainers must be holders of 2018 WT Coach Permit (granted by participation in a WT Coach Permit Seminar). Coaches/Trainers **that do not have valid 2018 WT Coach Permit shall pay a \$200.00 (USD) fine** at the registration desk. Poomsae and Kyorugi separately.

2018 WT Coach Permit Seminar will be held on July 11th at Davenport Hotel, Poomsae and Kyorugi separately.

Protector & Scoring System

The Organizing Committee will provide *DAEDO GEN 2* trunk protectors and *DAEDO GEN 2* E-Headgears for Kyorugi Competitions. Each athlete must bring his/her own *DAEDO* sensor socks.

WT/PATU approved *TaekwonSoft* Poomsae Scoring system will be used for all Poomsae competitions.

Recognized brands

Anti-doping regulations

The latest WT Anti-Doping Rules shall apply to 2018 Pan Am Senior TKD Championships via random test format approved by WT & WADA.

Indemnities

It is the responsibility of each Member National Association to ensure that their athletes and team officials have filled out the indemnification forms correctly and have duly signed by them, thereby indemnifying WT, PATU, Spokane Convention Center, the Organizing Committee and all other officials and athletes from any claims of injuries, losses or otherwise arising in the course of participation at the PATU official tournaments or any activities linked therewith.

It is the responsibility of each Member National Association to ensure and guarantee that sufficient insurance coverage has been arranged for all athletes, team officials and other participants. Without sufficient insurance coverage, national teams will not be allowed to compete.

Please fill out the Personal Indemnity Forms and return them to the Organization Committee before **June 29, 2018**. Each participant (athletes, team officials, etc.) **MUST** fill out the indemnification form.

Head of Team Meeting

The Head of Team meeting & Draw of lots shall be carried out by PATU technical officials on **Wednesday, July 11 at 16:00 hrs.** at Davenport Grand Hotel.

Seeding & Draw of Lots

25% of athletes will be seeded according to the latest WT athlete ranking as of June 31st, 2018. The draw sheets and brackets will be available one (1) day before the start of the competition of the respective weight category.

Weigh-in

The official weigh-in of the athletes shall take place one (1) day prior to the competition day of respective weight category. The official weigh-in shall be done by international referees appointed by the PATU referee committee.

Each athlete shall have one (1) attempt to pass the weigh in. However, one (1) extra attempt is allowed for those athletes who did not qualify at the first time. This extra attempt shall be done within the time limit of the official weigh-in. **No Random weigh-in on the competition day will be performed at this event.**

Transportation

Round trip airfares of the teams shall be borne by the participating Member National Associations.

All participating teams, officials, international referees and athletes are responsible for their own local transportation.

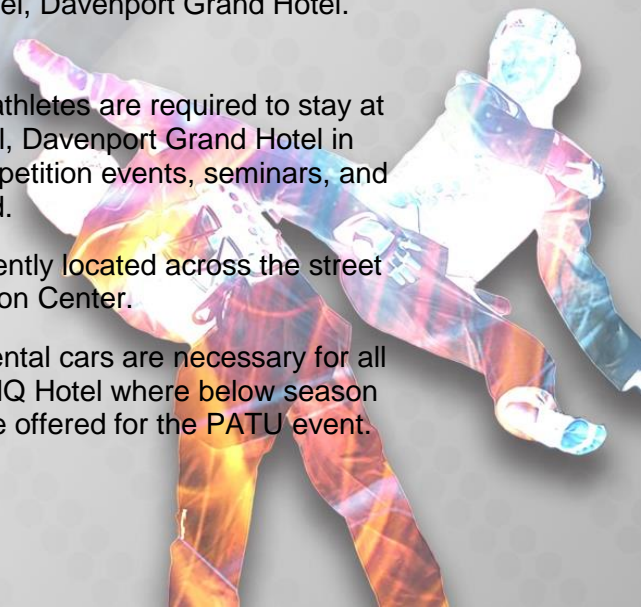
Airport shuttle service is available ONLY for participants staying at the event HQ Hotel, Davenport Grand Hotel.
